II Job description

The position is based in Bucharest where you will join our team as Analyst. You will work in direct contact with the rest of the team on broad range of advisory mandates (M&A and Project Finance) at all stages, across different geographies

It involves meetings and interactions with CEOs, CFOs, or senior executives. The position appeals to candidates with hands-on experience looking to embrace new opportunities

Your main tasks will be:

 - Perform financial analysis of projects or companies.



- o Build financial models, either on Project Finance or M&A transactions.
- Oraft and review marketing materials (teasers, info memos, other memos, etc.).
- Client / Investors relationship activities
 - Manage day-to-day interactions with lenders or investors.
 - Attend or lead meetings and negotiations.
- Transaction Execution
 - Monitor and facilitate due diligence processes.
 - Liaise and coordinate with external advisors (legal, technical, accountants etc.).
 - Manage Q&A process between investors and clients.

IV Conditions and contacts

V Recruitments / admissions

The recruitment period is opened, and candidates are invited to apply and submit their resume and motivation letters. After an internal review, the selected candidates will receive an email confirming their selection for the admission process.

Selected candidates will perform two interviews, one with the Human Resources representant and one with a Vice-President.

The interview will consist of two parts, one of a technical nature, where will be assessed the following: (i) financial knowledge, (ii) financial modelling skills and (iii) Excel and Power Point knowledge. The other part will assess the motivation of the candidate..

After the end of the recruitment period, a maximum of 2 weeks will be needed to assess the final selected candidate and all the candidates will receive feedback.
